

## Official Sweepstakes Rules

### Dubai DIFFerently

**1. DESCRIPTION: NO PURCHASE NECESSARY TO ENTER OR WIN.** A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. “Dubai DIFFerently” ("Sweepstakes") begins on 10/7/15 at 12:01 a.m. ET and ends on 10/23/15 11:59 p.m. ET (collectively, "Sweepstakes Period"). The administrator of this Sweepstakes is UrbanDaddy, Inc. ("Administrator") and the Sponsor of this Sweepstakes is UrbanDaddy, Inc. ("Sponsor") (and together, the “Sweepstakes Entities”).

**2. HOW TO ENTER:** During the Sweepstakes Period, visit [www.urbandaddy.com/tx/DubaiDIFFerently](http://www.urbandaddy.com/tx/DubaiDIFFerently) and follow the links and instructions to complete and submit the registration. Registration is free. You automatically will receive one (1) entry into the Sweepstakes each time you register during the Sweepstakes Period, subject to the following limit: one (1) registration per person and per email address per day during the Sweepstakes Period. For each friend you invite to enter the Sweepstakes through the method made available in the Sweepstakes entry pages, you can also obtain a “bonus” entry. Limit: ten (10) bonus entries per person and per email address per day regardless of the method of obtaining such bonus entries. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and if detected will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.
