

Official Sweepstakes Rules

Tee Party

1. DESCRIPTION: NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. "Tee Party" ("Sweepstakes") begins on Tuesday, March 4, 2014 at 12:01 a.m. ET ("Start Date") and ends on Monday, March 24, 2014 at 11:59 p.m. ET* (collectively, "Sweepstakes Period"). The administrator of this Sweepstakes is UrbanDaddy, Inc. ("Administrator") and the Sponsor of this Sweepstakes is UrbanDaddy, Inc. ("Sponsor") (and together, the "Sweepstakes Entities").

2. HOW TO ENTER: During the Sweepstakes Period, visit <http://www.urbandaddy.com/tx/TeeParty> and follow the links and instructions to complete and submit the registration. Registration is free. You automatically will receive one (1) entry into the Sweepstakes each time you register during the Sweepstakes Period. Limit: one (1) registration per person and per email address per day during the Sweepstakes Period. For each friend you invite to enter the Sweepstakes through the method made available in the Sweepstakes entry pages, you can also obtain a "bonus" entry. Limit: ten (10) bonus entries per person and per email address per day regardless of the method of obtaining such bonus entries (see mail-in option below). Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and if detected will result in disqualification. Proof of transmission or emailing will not be deemed to be proof of receipt by Sponsor and Sponsor will not verify receipt of entries. Entries delayed past the applicable receipt deadline will not be accepted. Sweepstakes entries become the property of Sponsor. 3. "Household Members" shall mean those people who share the same residence at least three months a year.
